



FEES

For students from ESSCA's exchange partners, tuition is waived. Other fees for the **Paris Summer Programme** for the four-week programme include:

- Course materials (there are no books to buy)
- Housing in shared (2-student) apartments in an international residence or an appropriate equivalent pending availability
- The welcome lunch and farewell dinner
- Some extra curriculum activities (venues can be changed according to availability and/or weather).

The fees do not include:

- Personal meals, food and beverages (except for the above-mentioned group meals)
- Personal expenses
- Insurance, visa and passport fees
- Personal travel and accommodations outside Paris
- Transport card in PARIS : you'll be given the transport card, "RATP smartcard" on which you'll have to put money to pay for your travel on public transport in Paris (metro, bus, tram)
- ⚠ • Tourist fee (taxe de séjour) to be paid to the hotel on arrival
